- 1. CITIZENS CANNOT HAVE IN THE CITIES A HEALTHY ENVIRONMENT DUE TO BOTH THE AIR POLLUTION AND POLLEN EXPOSITION, FOR A REGULAR HEALTHY OUTDOOR PHYSICAL ACTIVITY;
- 2. THE DEVASTING EFFECTS ON THE HUMAN HEALTH OF SUMMER HEATWAVES IN THE CITIES AND OF OZONE EXPOSITION IN A PARTICULAR TYPE OF VEGETATION IN THE SUNNIER HOURS OF DAY IN THE MEDITERRANEAN REGIONS OF EUROPE;
- 3. THERE IS A CHASM IN THE UE BETWEEN ITS CITIZENS AND THE INSTITUTIONS ALSO ABOUT THE AIR QUALITY INFORMATIONS DIFFUSION AND THE MUNICIPALITIES ARE ISOLATED, SO IT CAN CAUSE NEGLIGENCE, DEPOPULATION AND LOSS OF BIODIVERSITY;
- 4. THE ALLERGEN DIFFUSION FROM PLANTS CAN IMPROVE, IN BOTH URBAN AND NATURAL AREAS, THE EXPOSITIVE RISK TO THE CITIZENS AND CREATE SOME ECOSYSTEM DISSERVICES FOR HUMAN HEALTH.

- Defend citizens against the impacts of some environmental factors as air pollution, allergenic pollen diffusion, heatwaves and ozone pollution;
- -Reduce the potentially hazardous environmental exposures to health"(National Prevention Plan 2014-2018 of Ministry of Health), to interrupt the continue exposition to the pollution;
- Reduce the impact of the ecosystem disservices caused by the allergenic pollen diffusion and improve the forest social and recreational use, giving birth to some green areas safety for human health with the hypoallergenic flora;
- -Improve the management by medicine doctors of diagnosis, prevention, clinical monitoring and therapy of allergenic diseases in the urban and extraurban citizens.

Risultato del progetto

- A better social use of the forests for health protection by linking the project Breathing in the parks with the University of Granada (UGR), Department of Botany (Spain);
- -Two new digital maps in Umbria Region for recreative use of woods diffused:
- -The aerobiological network in Europe implemented with twonew points in the little cities;
- -High visibility standard for visually impaired persons and the respect of the INSPIRE Directive;
- new governance model synthesized and supervisored by an interdisciplinary Scientific Committee;
- -the Municipalities encouraged to apply the health promotion and the reduction of the expositive risk to allergens;
- -the Municipalities and the supporters will be linked in a European Airnet Network, that should link other Municipalities in the future;
- -Regional plan of prevention of summer warm in Umbria Region, by refuge-Oases in medium mountain locations.

- UE Life Program, which co-finance the project until 70%, the other cost of the program is owned by the Partners (C.R.E.A., A.R.P.A., DSA3 UNIPG, Municipalities, Public Sanity);
- Other financial instruments by Rural Development Programmes, in particular action 8 and 15 in forestry sustainable management; 16.5 and 16.8 in order to forest planning and cooperation betwen owners) and SNAI (internal areas strategy) that interest Parrano and Nocera Umbra municipalities.
